As stated in document "06 - 81289199 -Grid for assessing the eligibility" it is necessary to provide:</p> <p>At least 4 reference projects in the technical field "Sustainable and Green mobility" and at least 2 reference projects in Southern Asia in this technical field. All reference projects must have a minimum commission value of 1,0 Mio. EUR.</p> <p>Therefore, no III.1.3) of the EU publication should read:</p> <p>List and brief description of selection criteria: It is necessary to provide references in the technical field "<i>Sustainable and Green mobility</i>" with a minimum commission value of 1.000.000,00 EUR.</p> <p>Minimum level(s) of standards possibly required:</p> <ol style="list-style-type: none"> 1.
